

## DeMolay Foundation President's Report: 2022-2023

Good morning, Brethren and Ladies,

As I complete my term as Foundation President, I would like to take a few moments to reflect on some of the work the Foundation has accomplished this year. First, I would be remiss if I didn't say thank you to the Foundation's Board Members for your hard work and support. As we continued to recover from the pandemic and resumed a more normal life with meetings and activities, we were then hit with a market pullback that greatly hindered our fund-raising efforts.

The Foundation Trustees have continued to concentrate our efforts on the four basic strategic core pillars of Building, Leadership, Education, and Endowment. Development takes a concentrated effort of cultivating existing and potential donors and is an integral part of what we do. Listening to donors, building relationships, and communicating with them on a regular basis is critical to success. We have an excellent group of Trustees, and I am grateful for their continued work on our development efforts.

This year, we look forward to the addition of \_\_\_\_\_ and \_\_\_\_ as a Trustee, joining Richard Lynn, Aaron Habben, Steve Doan, George Braatz, Fred Baerenz, Brian Dodson and myself. This year we are losing Kerry Campbell and Allan Iding as their terms as Trustees are expiring. We thank them for their past service to the Foundation and DeMolay in general. Please join me in thanking Kerry and Allan for their service.

This year, on Sunday, January 29<sup>th</sup>, the Trustees and the Grand Line of DI, met via ZOOM, for our annual mid-year meeting of Trustees. We had an excellent meeting with a lot of great discussion and strategic planning.

As Foundation President, I am pleased to share a few highlights of our Trustee's work this past year, and some plans moving forward:

- We changed the method of how the Foundation will support the programs of DeMolay International. In the past the Foundation Trustees chose which programs to fund depending on available funds for each year. This year the Trustees adopted a funding plan of 4% of the investable assets as of the end of each year that will be granted to DeMolay International for programs. The Grand Master along with the Board of Directors will now decide which programs are funded for each year. This approach allows the Trustees to focus on the growth of our assets and not be involved in which programs are funded. We hope this will allow for greater funding of DI in the future.
- We have reviewed major development plans for the Service and Leadership Center:
  - We have completed the parking lot project funded by the Sunderland Foundation's grant. We also upgraded the outside parking lot lights and the momument sign facing the interstate side of the building.
  - We are reviewing opportunities to update the restrooms, conference space, utility systems, and a professional display area or museum room for historical regalia, documents, and other artifacts.

- We continue to work with Hartsook now renamed to Kinetic as our professional fundraising team. Their main focus is on donor stewardship. We have worked to be very strategic in our approach to donor prospects and what we are asking them to support. DeMolay International and DeMolay Foundation work together to brand our organization, so we need to work together to show our donors how their support impacts the program, and more importantly, the young men of DeMolay. As you know The DeMolay Foundation has focused on Four Pillars:
  - Building The Service and Leadership Center
  - o Leadership The Leadership Training Conference's and Field Representatives
  - Education Scholarships
  - Endowment
  - And last, but certainly not least, I am proud to announce that this year, the DeMolay Foundation will award \$45,000 in scholarships.

## In Development:

We have asked Brother Johnny Onkst to take on the role of Chief Development Officer for the Foundation. Johnny's main focus will be to work hand in hand with Kinetic and our Masonic partners to ensure the development of a long-lasting relationship.

Over the next 12 months, there will be a greater focus on in-person cultivation opportunities. Our development team and Trustees are working together to plan 10-12 cultivation and fundraising events in strategic parts of the country. Engaging others and building lasting relationships are cornerstones of successful major gift fundraising, and we are ramping up our efforts to provide those opportunities.
